CALL FOR ABSTRACT

Submission Guidelines

GENERAL RULES

- 1. Ethical approval:** Studies involving human participants should have received approval from an appropriate Ethical Committee before submission. While not mandatory, authors are strongly encouraged to ensure that their research complies with ethical standards.
- 2. Submission platform:** Abstracts must be submitted exclusively via the official email address abstracts@osstem.eu or through the submission form which is linked on the "Call for Abstract"-page.
- 3. Deadline compliance:** Abstracts submitted after the deadline will not be considered.
- 4. Author responsibility:** The submitting author is responsible for ensuring that all information provided in the abstract is accurate and that all co-authors have approved the submission.
- 5. Originality:** Submitted abstracts must present original work that has not been previously published or presented at another scientific meeting.
- 6. Language:** All abstracts must be written in English. Authors are kindly requested to carefully check the grammar and style of the English language before submission.
- 7. Presenter registration:** At least one author (the presenter) must register by October 31st for the meeting to display the accepted abstract. Failure to register may result in the removal of the abstract from the scientific program.
- 8. Poster Display:** Poster Display (13. – 14. Nov.) & Oral Presentation (On-Site on 13th of Nov.).
- 9. Categories:** Abstracts may be submitted under one of the following categories. Pre-clinical research; Clinical research; Case report; Photoshoot (Clinical Photography or Photographic Case). Each abstract may be submitted in only one category. Please note that the OIC Abstract Jury reserves the right to reassign an abstract to a different category if deemed appropriate.
- 10. Award:** By submitting an Abstract, authors will automatically be considered for the Best Research/ Abstract Award (one award per topic, Award Ceremony, November 14th 9.00 AM). To facilitate communication and ensure smooth organization, the WhatsApp number of the presenting author will be requested during the submission process.
- 11. Use of generative AI:** Authors confirm that generative AI tools have been used only to improve the English wording of the abstract.
- 12. Conflict of Interest and Funding:** Authors must include a statement disclosing any conflicts of interest, sources of funding, or financial support, if applicable. If none exist, authors should clearly state "The authors declare no conflict of interest and no external funding."

ABSTRACT STRUCTURE

1. General:

- There is no specific word limit for the abstract. However, authors must strictly follow the template provided, respecting the designated spaces for each section.
- Title of the presentation (maximum 25 words). The study design must be reported in the title.
- All co-authors and their affiliations must be reported. The presenting author should be indicated with an asterisk (*), while numerical superscripts should be used to identify the corresponding affiliations.
- All text must be written in Times New Roman, 36/26 pt, as indicated in the template.

2. Introduction: The Introduction section should clearly present the background and rationale of the study.

3. Materials and methods: Provide a brief description of the study design, materials and methods used to conduct the study, including pictures and tables (if relevant).

4. Results: Summarize the main findings of the study, highlighting the most relevant data and outcomes.

5. Conclusion: Clearly state the main conclusions of the study and their clinical or scientific relevance.

6. References: Include the most relevant references supporting the study, following the citation format indicated in the template.

7. Figures and Images: Figures and images may be included in the poster and should be of high resolution to ensure optimal quality for evaluation and presentation.

8. File Format: The poster must be submitted in PDF and PowerPoint (PPT) formats, following the template provided.

By submitting an abstract for an oral presentation or ePoster, the author grants the OIC European Meeting organizers the right to use the content of the oral presentation or ePoster for educational purposes and within the OIC European Meeting online resources or scientific archives.

By submitting an abstract, authors also authorize the OIC European Meeting organizers to store the contact details of the submitting author and co-authors for purposes related to the organization and management of the congress, for a maximum period of three (3) years.

Please note that photographs and/or videos may be taken during the congress. These materials may be used for future OIC communication, marketing, and promotional activities. Participants who do not wish their image to be used are kindly requested to inform the congress organizers in advance.
